



Use this checklist to help keep you on track as you create your emergency plan that incorporates the care of your horse and barn management in emergency-like situations.

## FOUR BASIC CONSIDERATIONS

- Who will care for the horses if I fall ill or are otherwise unable to care for the horses?
- What feed and supplements are the horses getting?
- Do you have enough feed, hay & supplements to last 30 days?
- Do I have an emergency fund and emergency cash available?

## EMERGENCY FUND & CASH

- 3-6 months of expenses
- 1 months' worth of emergency cash

## EMERGENCY FEED, HAY & SUPPLEMENTS

- At least a 30-day supply of feed, hay & supplements

- Horse Owner & Owner's Emergency Contact
- Business/Barn Emergency Contact-Caretaker
- Veterinarian, Farrier & Other Equine Health Professionals
- Hay, Feed & Supplement Supplier
- Barn Staff
- Power of Attorney (depending on the circumstances)
