President's Message: New York State Horse Council, Inc.

We finally have some glorious riding weather after experiencing a roller coaster spring of late frost and then very high heat (we had 90-degree F weather here in Allegany County). Some of the trees and shrubs hit by the late hard frost look dead, especially the locust and sycamore, but look closely, the leaves are showing new growth.

That is the kind of resiliency I have experienced here at the New York State Horse Council. COVID hit us hard in many ways, and even though some refer to "post Covid" years, it is still with us but not in the magnitude of shutdowns and inability to find Contractors, staff, and materials for trail construction.

People are flocking to participate in outdoor activities in record numbers. It is difficult to organize an event that does not conflict with three or four others. Horse shows, trail rides, and clinics are under way. Kudos to everyone in the planning and organizing of these activities that provide these great experiences for other riders.

Thanks to the team of dedicated Horse Council Board members who have worked diligently over the winter and early spring to review the New York State Horse Council bylaws and chapter agreements. The New York State Horse Council is a non-profit 501c3 organization and is required to follow the non-profit corporation laws of New York State. NYSHC also joined the New York Council of Non-Profits (NYCON) this year. NYCON provides Board of Directors training and other services.

Please remember to take the National Equine Economic Survey. The link is posted on the NYSHC website. The resulting important information may be used when talking to legislators about various equine related issues in New York State. As horsemen, we appear to be losing ground in access to trails. We need to be able to demonstrate that horses are still an "economic engine" for New York State. I also encourage you to develop good relationships with your local, state, and federal legislators and Park Managers.

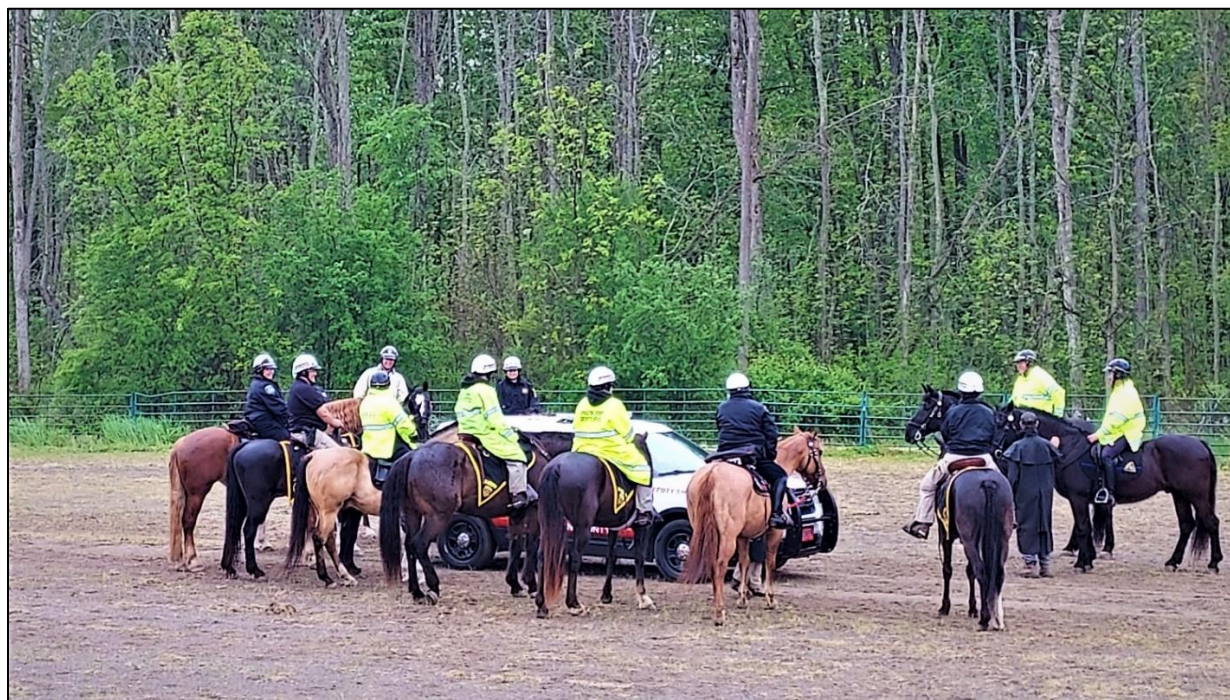
Harriet Hollister Spencer Recreation Area (HHS) is one of the areas that has been closed to horses until further evaluation by the State Park manager. I have had recent conversations with him on the trail at Stony Brook State Park. The trails at HHS are being evaluated to improve wayfinding and safety for all users. I encourage all the Horse Council members that read this newsletter, to write a letter to your state representative to encourage horse use at that facility. There is also an opportunity to support an education program of how trails can be shared, sponsored by the Equine Land Conservation Resource called Trails Are Common Ground <https://elcr.org/>.

If you are in western New York, I encourage you to visit the trails at the DEC West Almond Trail System. Trail 4 is complete, and the gravel has settled. The horse campground on Stewart Forest Road is open with 16 straight stalls, water, a handicapped mounting block, and 5 covered picnic tables with fire rings. A generous donation of hardware for the straight stalls from Sue and Jim Knauer make it easier to hang water buckets and hay bags. The trails are in good condition with this dry weather. Ash trees are being removed and there are downed logs and slash, but please use the dry wood for campfires in the fire rings.

IMPACT: Friends Improving Allegany County Trails, Inc. is completing the Master Plan for the West Almond Trails with the National Park Service, NYSDEC, and Alfred University. This is a living document, intended to prioritize future trail projects. If you ride the trails, please send me comments of what you like, and what you recommend for future improvements.

The Mounted Patrol Training Techniques Clinic was rained out on May 20, and officers participating in that clinic were not able to reschedule for Sunday. We may be able to offer this valuable training in September in the Finger Lakes Region if there is enough interest. I was able to attend the “spring tune up” for Mounted Patrol officers from the Rochester Police Department, Monroe County Sheriff’s Department, Livingston County Sheriff’s Department and Niagara County Sheriff’s Department. Thanks to Instructor Gary Cicoria for inviting me. It was valuable to watch, as the officers do more advanced training with gunshots, smoke, and following a moving police car with lights and siren active! (see photo below)

Have a wonderful safe summer. We anticipate having the Annual General Membership meeting in mid-October at Cornell University after the annual fall pleasure ride at the Madison County Fairgrounds. A great program is in development, watch the NYSHC website for more information.

She has been a Premier Director of the NYSHC Board of Directors for decades in the Western Region and serves as the Secretary of the East Aurora Driving Society Horseshow.

7 Tips to Decrease Health Risks of Summer Travel

Horses are creatures of habit. They're designed to be healthiest when they're in a herd out in a field, grazing all day. Nearly anything else causes some level of stress, let alone loading them in a metal box to take them from their home and herd.

Risks from travel include: weight loss, dehydration, respiratory infections, gastric distress that could lead to colic, and muscle fatigue. All of which we definitely don't want our horses to experience in general, but will also certainly decrease their performance at the show.

The Impacts of Travel

Hauling your horses is exercise. Research from the University of California, Davis has shown that horses can lose 0.45 to 0.55% of total body weight per hour of transport¹. So, if you have an 1100lb quarter horse, that's 4.95-6.05lbs per hour. On a 5 hour trip, your horse could lose over 30lbs. This is a good indication of the toll travel can really take on your horse.

Muscle Recovery & Stamina: The faster your horse recovers, the more energy they'll have to perform. So, it's important to consider the time it will take for their body to replenish energy, mostly stored in their muscles in the form of glycogen. (Bonus tip: this is part of the reason why horses will experience muscle fatigue resulting in more stumbling).

Digestive Health: The stress from travel can also cause gastric distress and negatively impact the health of the microbiome - responsible for many things including supporting healthy digestion of fiber in the hindgut, blocking bad pathogens and toxins, boosting the immune system and more.

Respiratory Health: Did you know? Studies have shown that tying heads in an upward posture for long periods of time makes it more difficult for horses to get rid of foreign particles in the trachea, leading to more bacteria in the respiratory system and infections. The stress from travel also decreases the immune system's ability to fight off viruses and bacteria - further contributing to the risk of infection.

Recommendations to decrease the risks of travel stress, promote overall well-being and improve performance.

1. **Provide adequate rest time** after hauling (recommend 1 day for hauls between 6 and 12 hours, and 2 to 3 days for trips over 12 hours)
2. **Stop frequently to provide water**, and check for dry feces. With dehydration being another risk, this could also compound the negative impacts on muscle recovery.
3. **Keep your horse's respiratory system healthy**, by ensuring the trailer is clean and has good ventilation.
4. **Tie heads as low as possible**, to help prevent respiratory infections, while still being safe and allow slack for movement
5. **Supplement with [Chromium Propionate](#)**, recently approved by the FDA's Center for Veterinary Medicine, shown to help increase the uptake of glucose by cells - leading to faster replenishment of stored energy in the muscles.
6. **Take your hay, grain and supplements with you** to prevent disruption to the digestive system. Don't change anything, if you can.

7. **Further support the digestive system** with [pre and probiotics](#), and/or a [foregut buffer](#).

CARRIAGE DRIVING SHOW RETURNS TO BATAVIA

Northampton Driving Society's 37th annual carriage driving competition returned to Silver Shoe Farm in Batavia on Sunday, June 25. Kacy Tipton-Fashik, the general manager of The Grand Oaks equine resort in Weirsdale, Florida judged the event. David Remley, whose late parents founded the internationally-known Walnut Hill Driving Competition, was the ringmaster.

Morning classes featured horses, ponies, very small equines and multiples of the same in the ring for working and reinsmanship classes. These are judged on "turn out" – the pleasing appearance and appropriateness of horse, harness, vehicle and attire – the horse's obedience and way of going and the driver's (the "whip") reinsmanship skills. Afternoon classes entailed driving an obstacle course of cones, scoring for speed and agility.

Mr. Remley commenced the show with a coach horn demonstration at 9 a.m. Food and shopping opportunities were provided by Burning Barrel BBQ, Buttercrumbs Bakery, The Brick House Boutique, Rusty Bitz, Green Compass CBD, and Creative Upcycling.

Silver Shoe Farm is a lovely facility at 3336 Pratt Road in Batavia, operated by the well-known Cable family of blacksmiths and Nicole Cable, herself a carriage show competitor, judge and trainer.

Are you Aware of What is Happening in Your Towns

There is a proposed housing development on the land currently being operated as a public boarding stable in Huntington, NY (Long Island). There residents in the area are getting together to fight the proposed downzoning. The owner wants to sell the development rights to the Town or the County so it remains a horse property. The Town would be fine with it being downsized to a certain degree. The current zoning is 2 acres. The proposal is for 1/4 acre lots. The Town has approved such down zoning before with large parcels by “cluster zoning” where they carve out a larger lot, about 5 acres for “open space” and then make the rest much smaller lots. These do not fit in with the surrounding area.

With the loss of Thomas School of Horsemanship, Greenlawn Equestrian Center and Indian Head Ranch to “cluster zoning” housing, the loss of Stanhope Stables would be devastating to the local horse community. The resistance to the proposed plan has taken off on Facebook where the group [Huntington Residents Against Development at Stanhope Stables](#) has started a petition against the rezoning which has over 1,200 signatures. The local horse community is also on board. Their hope and goal is to have the development rights of the property purchased by the County or Town and the stable continued to be operated as a public riding and boarding center. The owner of Stanhope, Nancy Henderson, has tried in the past to get the development rights sold to preserve it as farmland but with no luck. She is hopeful this time, with more community support, that the development rights will be purchased. It is still early in the process. Support from the horse community is critical for the success of this happening.

Humane Committee Report May 2023

It appears there is still a need for clarity on the cruelty laws pertaining to horses, and additional training throughout NY. I had been in touch with NYS Humane Association, who advised that although they historically offered various trainings, things had changed and NYS Department of Agriculture and Markets should be involved. I asked if there is anything we can do to help and was directed to call NYS Ag and Markets. I had requested assistance at the last meeting with contacts in Albany, Pauline Burns tried but as of a few weeks ago was unable to assist.

I reached out to Ag and Markets, asked if they were offering and training and asked if the horse council could be of assistance. I was advised that they do not have an active training program but if law enforcement requests training pertaining to husbandry practices they would assist in that way. At this time, I am in touch with New York Humane Association who will be researching training options.

Hudson Valley Community College will be offering two new classes this fall, considered to be microcredentials, not a degree program, but can be applied toward a degree. Animal Law and Ethics and Animal Law Enforcement. You can take one course or both, they are online.

GOVERNOR HOCHUL ANNOUNCES \$1.8 MILLION IN GRANTS AWARDED TO STATE PARKS, TRAILS, HISTORIC SITES AND PUBLIC LANDS PARTNER ORGANIZATIONS

Governor Kathy Hochul today announced \$1.8 million in grants to support 28 not-for-profit organizations involved with stewardship of state parks, trails, historic sites and public lands, the highest amount awarded in the Park and Trail Partnership Grants program history. The grants support partner group efforts to raise private funds for capital projects, engage in maintenance and beautification projects, provide educational programming, and host special events that promote public use of the parks.

"We are proud to support the work of the incredible grassroots partner organizations that elevates the stewardship and programming of our state parks, historic sites, trails and public lands," **Governor Hochul said.** "With the largest investment in the Park and Trail Partnership Grants program history, New York State is sending a message that we are deeply committed to protecting and funding our public lands as we continue to embark on nation-leading climate resiliency initiatives."

Some of 2023 awardees will benefit the Equine population.

Capital Region

Lake George Battlefield Park (Fort George) Alliance (\$50,000) for the hiring of a Member Services Manager to promote awareness of the park through marketing, fundraising, and operation of the new visitor center. (Horses at Luzerne & Bear Spring Mountain allowed with proof of current negative coggins certificate. Out-of-state horse owners required to produce 30-day health certificate & patrons must carry horse's health papers with them at all times)

Finger Lakes

Friends of Letchworth State Park (\$8,000) for plans to upgrade access to three picnic shelters and one comfort station in the park to better serve park visitors with physical limitations

Western New York

- Chautauqua County Equestrian Trail System (\$68,000) to develop a multi-year strategic plan focusing on marketing, fundraising, and volunteer support to broaden the diversity of trail users and expand and strengthen partnerships.
- IMPACT: Friends Improving Allegany County Trails (\$7,396) to replace a 30-foot bridge to be built in partnership with Alfred State College and the DEC, and to install two trail counters for data collection on nearby trails.
